This document affects your legal rights. You must read and thoroughly understand it before you sign it.

STATEMENT OF RISKS: There are significant elements of risk in any adventure, sport, or activity associated with watersports, the outdoors, the presence or use of motorized watercraft, the presence of any land vehicles, in close proximity to wildlife on land or sea, and activities incidental thereto (referred to herein as "the Activity").
